



## Haul About LLC. Limited Warranty

Haul About LLC warrants the original purchaser that the product will be free from defects in materials and workmanship by Haul About LLC. The warranty does not include warranties on components or products used in the manufacturing of this product which may or may not have their own warranties, such as: tires, wheels, couplers, electrical, axles, jacks, fiberglass, aluminum components, seals, windows, doors, and awnings. Components and other products that are warranted through our suppliers are not warranted by Haul About LLC.

Haul About LLC. will repair or replace at its cost, and at its discretion, any Structural Defect in factory materials or workmanship of Haul About LLC. for a period of (1) year for Lynx and Cougar or (3) years for Panther, Leopard and Tiger from the date of original purchase. A "Structural Defect" pertains to a defect in the metal frame, members welded to the frame, studs and framing in walls or roof members to which any of such defects that cause the trailer to be unfit or unsafe to normal operational conditions. Paint and undercoating are not included in our warranty. Be aware that extreme temperatures and situations may cause bonded exterior metals to become loose and will not be covered by warranty. In the case that glued seams or side panels become loose from the sidewalls, Haul About LLC. Reserves the right to either apply screws to the loose skin or re seam the trailer.

For Warranty to be honored, the customer must promptly contact the dealer from which your unit was purchased to make a warranty claim. Your dealer will then be required to initiate the claims process. Reasonable notification and time will be allowed for performing warranty repairs. Loss of time, inconvenience, loss of revenue or other commercial loss is not included under this warranty. You must pay all incidental expenses incurred in obtaining warranty service, including but without limitation, transportation of the product and delivery charges to and from the dealer or manufacturer.

Warranty will be void if product is misused. Warranty will not be applied if: the trailer has been altered or modified beyond Haul About specifications. Overloading, lack of preventative maintenance, use for other than what the trailer is designed, unauthorized repair or installation, damage due to normal wear and tear, exposure to salt, or corrosive chemicals used by highways to melt snow and ice and damage as result of an accident will not be covered under warranty. If the trailer has been modified in any way without approval from the manufacturer, the warranty will be void. Haul About LLC. Reserves the right and final say on decisions as to whether the purchaser has misused the product.
